EMERGENCY OVERVIEW:

POTENTIAL HEALTH HAZARD

Eye:

Contact may cause mild transient irritation. Some redness and/or stinging may occur.

Skin:

Not expected to be irritating, sensitizing, photoallergenic or phototoxic when used as intended. If irritation occurs follow intended use or prolonged contact it is expected to be mild and transient

Inhalation:

SECTION 4: FIRST AID MEASURES

Eyes: Immediately flush with gentle, but large stream of water for 15 minutes, lifting upper and lower eyelids occasionally. Remove contact lenses if present easy to do, continue rinsing. Get medical attention if irritation develops.
